STATE OF MISSISSIPPI GENERAL FUND BUDGET
FOR FISCAL YEAR 1996

The Joint Legislative Budget Committee feels that an explanation of the General Fund receipts anticipated and appropriations authorized for Fiscal Year 1996, as well as the ending balance anticipated on June 30, 1996, should be made in examining the schedule found in the Fiscal Year 1996 Appropriations Bulletin.

As you will note from the statement found on page three of the Bulletin, it is estimated that an unencumbered balance of \$11,070,612 will remain in the State Treasury on June 30, 1996.

The Fiscal Year 1995 appropriated figures contained in this report are the amounts actually appropriated by the 1994 Legislature and Extraordinary Legislative Session of 1994 plus all deficits and additionals appropriated by the 1995 Legislature.

Total current and deferred General Fund appropriations made by the 1995 Legislature amounted to \$2,681,081,889. The Legislature appropriated or authorized \$3,570,339,608 from Special Fund sources including Federal Funds for the operation of all General Fund agencies and functions during Fiscal Year 1996. The Fiscal Year 1996 budget is \$11,576,452 more than the Fiscal Year 1995 appropriated budget or an increase of 0.43%.

The General Fund budget increases and decreases by major categories as appropriated are for the following purposes:



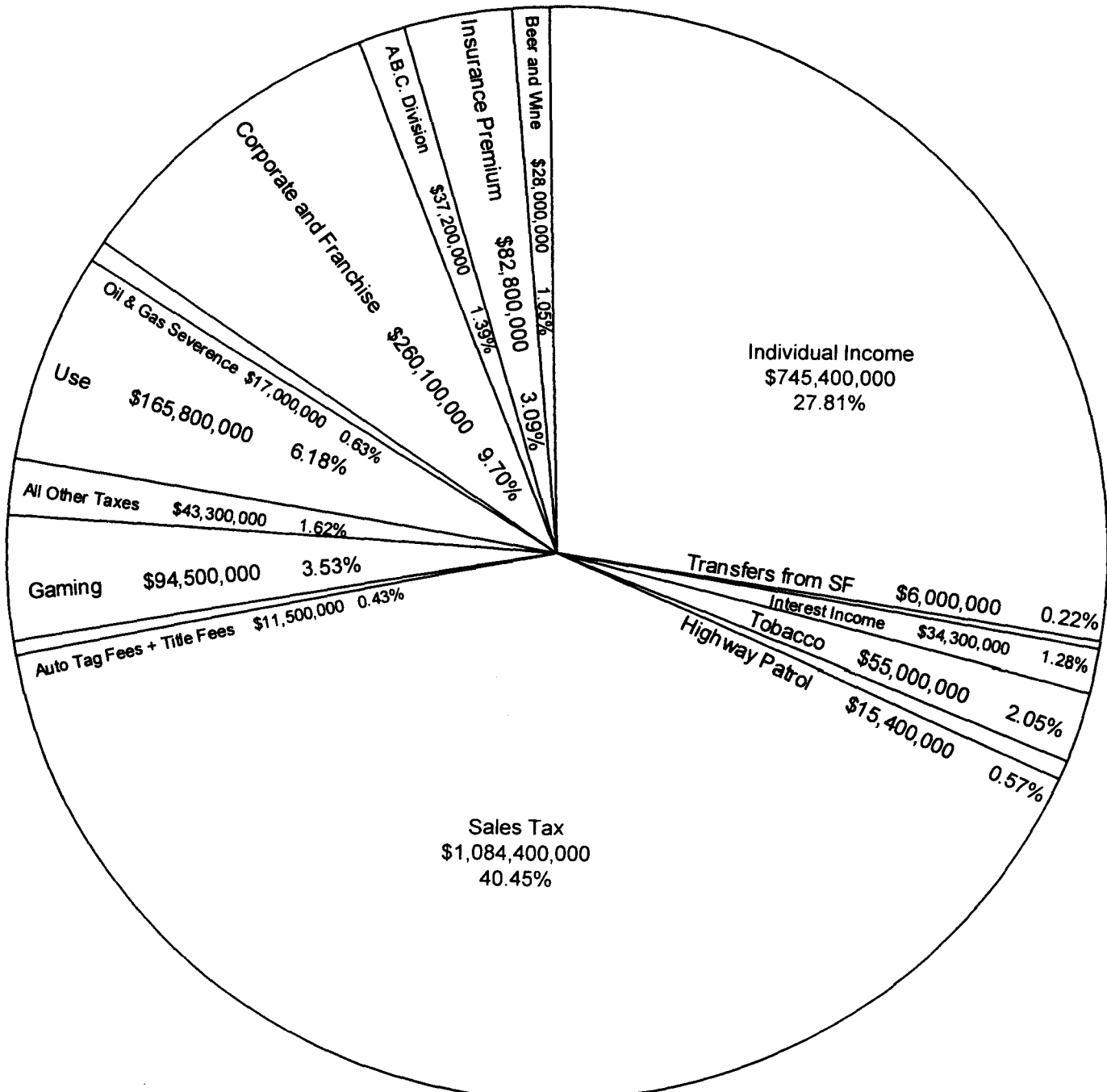

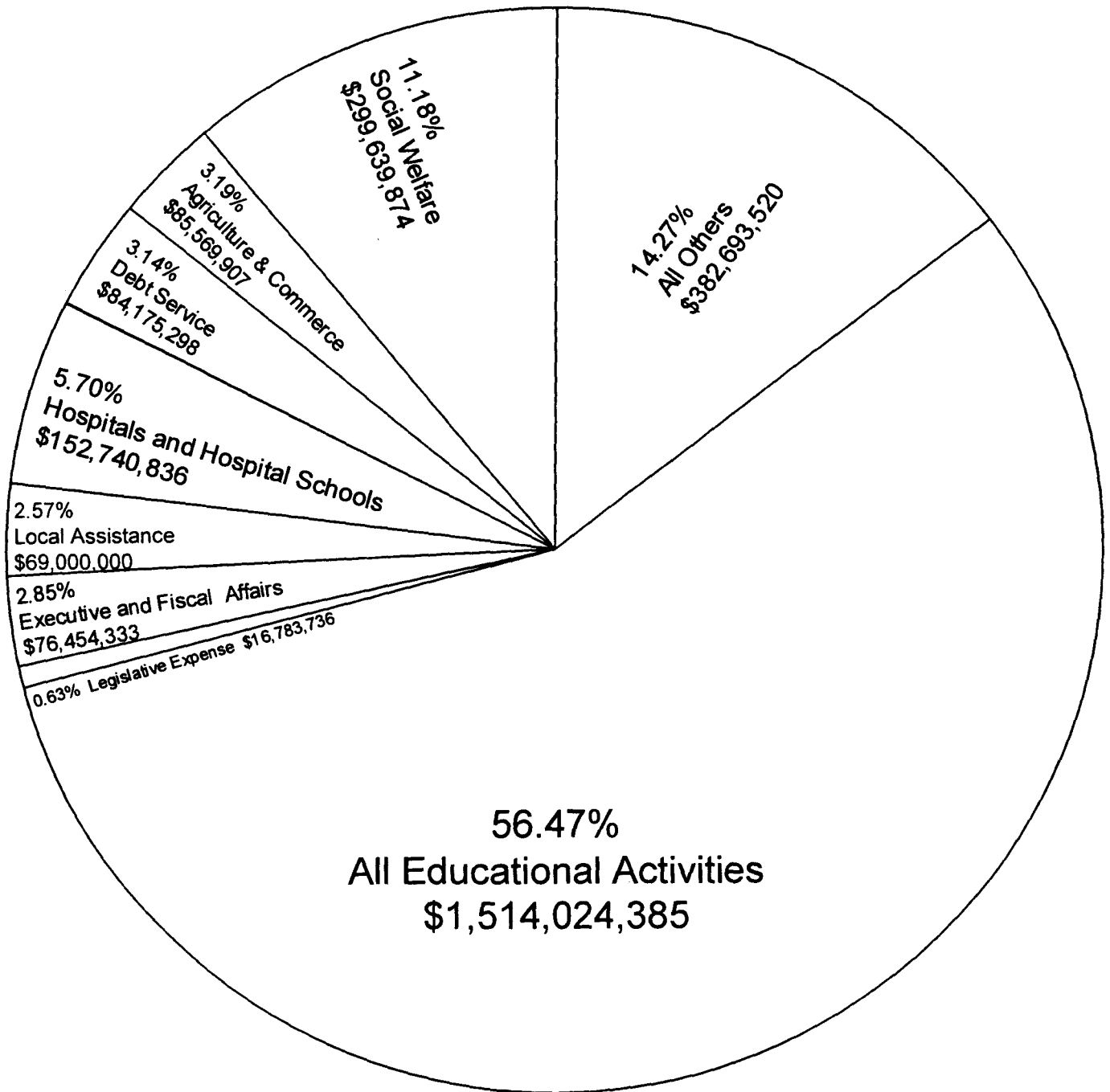
