STATE OF MISSISSIPPI GENERAL FUND BUDGET
FOR FISCAL YEAR 2010

The Joint Legislative Budget Committee believes that an explanation of the General Fund receipts anticipated and appropriations authorized for Fiscal Year 2010, as well as the ending balance anticipated on June 30, 2010 should be made in examining the schedules found in the Fiscal Year 2010 Appropriations Bulletin.

As will be noted from the statement on page three, it is estimated that no unencumbered budget balance will remain in the State Treasury on June 30, 2010.

The Fiscal Year 2009 appropriated figures contained in this report are the amounts actually appropriated by the 2008 Legislature plus all deficits and additional appropriations by the 2009 Legislature.

Total current General Fund appropriations and reappropriations made by the 2009 Legislature for Fiscal Year 2010 amounted to \$4,756,212,251. The Legislature also appropriated or authorized \$15,033,260,641 from Special Fund sources and reappropriations including Federal Funds, Budget Contingency Funds, Education Enhancement Funds, Health Care Expendable Funds and Tobacco Control Program Funds for the operation of all agencies and functions during Fiscal Year 2010. The Fiscal Year 2010 General Fund budget is \$267,460,326 or 5.3% less than the Fiscal Year 2009 appropriated budget.

The General Fund budget increases and decreases in the Fiscal Year 2010 appropriations are summarized below:

It should also be noted that the Legislature authorized General Fund Transfers of \$149,672,000 for Fiscal Year 2010, which included \$146,672,000 to the Budget Contingency Fund and \$3,000,000 to the University Medical Center - ACT Center Fund.

In addition to the General Funds noted above, the Legislature appropriated \$251,354,730 from the Budget Contingency Fund for Fiscal Year 2010. Details on the Budget Contingency Fund can be found on page 23.

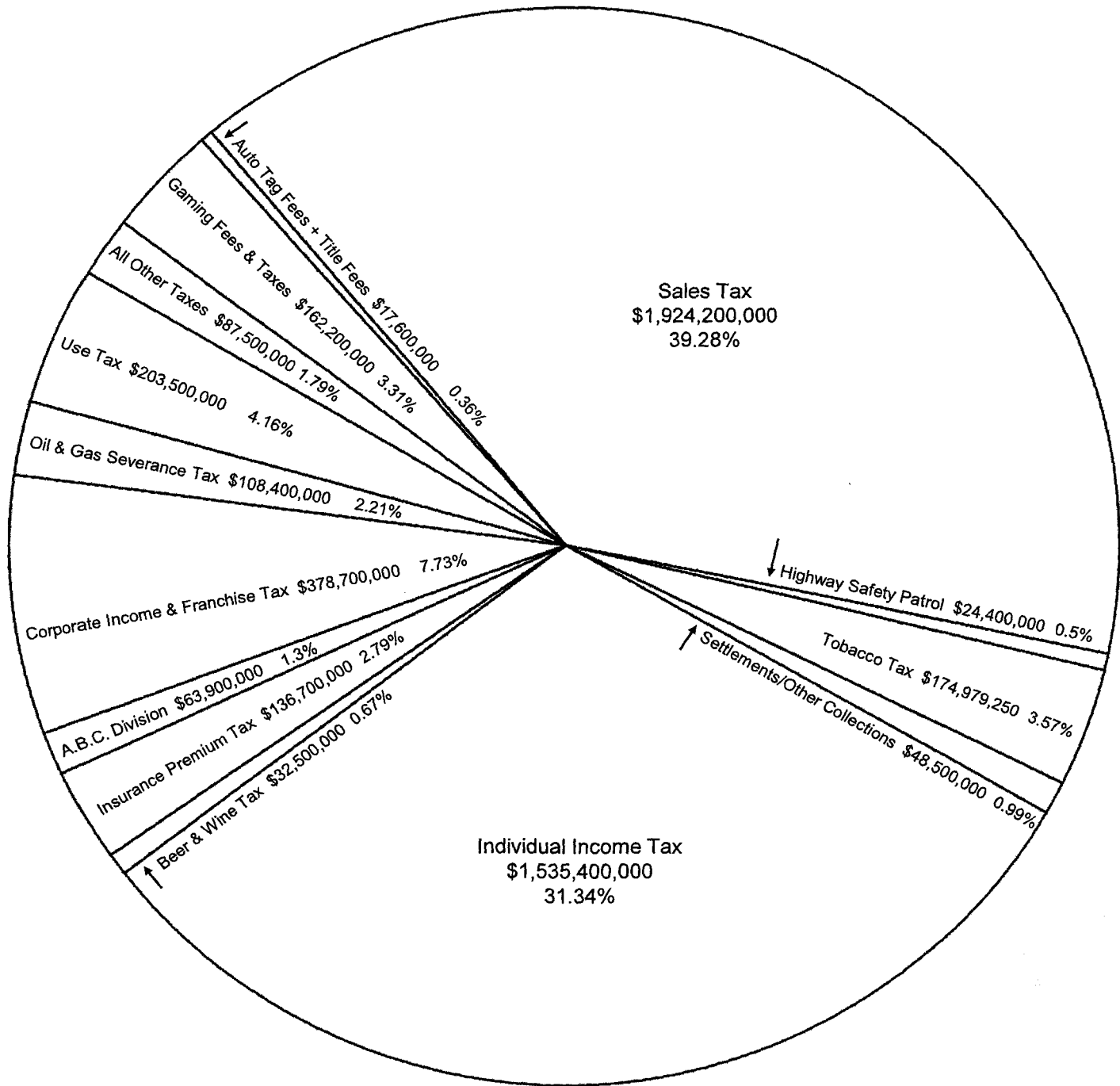

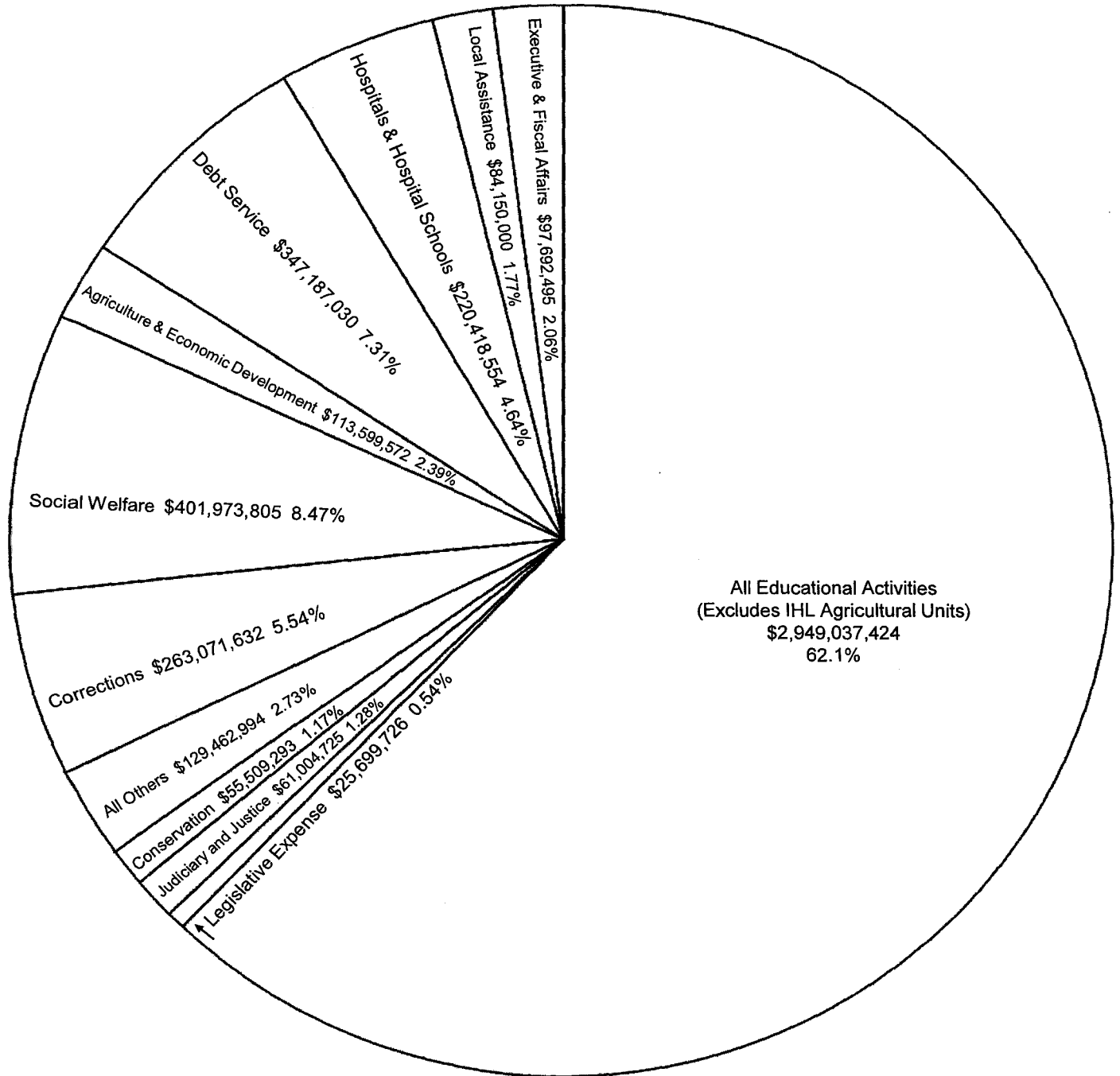
